THOROUGHLY SCREENED VOLUNTEERS TO FULFILL THE ORGANIZATION PROGRAMMATIC OBJECTIVE. 47 HIGHLY QUALIFIED VOLUNTEER WERE SWORN INTO SERVICE DURING FY12 AND THEY EACH TOOK A CASE UPON COMPLETION OF TRAINING. 
